1. ELIGIBILITY - PARTICIPANTS

3/5 year Law pursuant from any University.

2. TEAM COMPOSITION

Team shall be of three members (Two Mooters & One Researcher Only).

3. LANGUAGE

THE LANGUAGE SHOULD BE ENGLISH ONLY.

4. DRESS CODE

PROPER ADVOCATE ATTIRE ONLY.

5. REQUIREMENTS FOR THE PARTICIPANTS

The expecting participants are hereby informed that they will have to prepare their memorial from both the sides. ***THEY WILL ALSO HAVE TO SUBMIT DULY 8 (EIGHT) HARD COPIES OF THE SAME AND ONE SOFT COPY IN ADVANCE.***

The memorials have to be sent by post or hand delivered as according to the comfort of the participants.

6. JUDGEMENT AND PENALTIES

The decision of the judges will be final and binding.

ANY KIND OF APPEALS AGAINST THE SAME WILL NOT BE ENTERTAINED BY THE COORDINATING COMMITTEE OR ANY FACULTY INVOLVED.

The rules of the competition are to be followed strictly and any non-adherence of the same will amount to penalties and even disqualification from the Competition altogether by the organizing team.
