ABOUT THE CONFERENCE

The communal forces are actively propagating the myth that secularism is a new mask of fundamentalism. They denigrate the secular policies, which are a hindrance to Hindu Right's unobstructed march to subjugate the oppressed in general and minorities in particular. The conference aims to exercise on this theme. Must India lose its religious diversity comprising of Muslims, Sikhs, Buddhists, Jains, Christians and tribal gods to this rough shod hounding of the Hindu fundamentalist? Where will it halt?
