GUIDELINES FOR AUTHOR(S)

⊙ *The Following is the suggested format for Paper Submission :*

- ◆ The abstract should summarize the key points of the paper with a maximum of 5 keywords that define the subject matter.
- ◆ Manuscripts submitted to Online International Conference should be original contribution and should not have been previously published nor under consideration for publication elsewhere. Individual and multiple authors are welcome to contribute.
- ◆ Manuscripts must be written in UK English.
- ◆ An original article would normally consist of 5000-7000 words (excluding figures, tables and references), although high-quality articles which exceed 7000 words will be considered.
- ◆ All contributions should follow the format and style described in the Publication Manual of the Harvard (name and date) short reference system for citations in the text with a detailed alphabetical list at the end of the article
- ◆ All manuscripts should be typed in MS WORD format, in single or double spacing, preferably in Times New Roman size 12 font. All accepted articles will be correctly formatted for publication.
- ◆ All tables should be appropriately named and numbered.
- ◆ Manuscripts should include the following major sections & sequence: Title : as short as possible, with no abbreviations or acronyms. • Abstract : approximately 100 words, maximum 150. • Keywords : 10-15 keywords or phrases. Address* : position, department, name of institution, full postal address and email address for each author. • Biographical notes* : approximately 100 words per author, maximum 150.

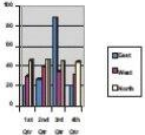
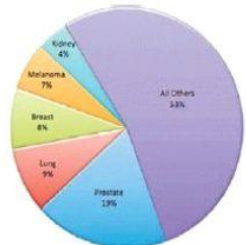

Your poster should include following elements:

Do not use all uppercase letters for the title or body of the poster.
