Brief Summary:



Learning Outcome:



2nd Position: Khushi Kalra, Shivik Singhal, Palak Nahata(BBA-1st shift)




The moderation was concluded with a Q&A round where the participants actively asked queries and the speaker elegantly offered cogent answers, marking the end of a very illuminating discussion.



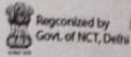

Objective:

The aim of the workshop was to understand the need of Anti-Trust and Intellectual Property protection promoting efficiency in the market and preventing market distortions.

Brief Summary:

The speaker of the day, **Ms. Jyotsna Yadav, Joint Director General, Competition Commission of India**, started her lecture why there is a need of Competition laws in the market, she also shared that Markets are prone to distortion by market players, suppliers, buyers and intermediaries. She also emphasized on the Licensing practices or conditions that may have an adverse effect on competition examined through appropriate measures, including regulation of anti-competitive conduct in the market by the Competition Commission of India. She shared in her exceptional lecture that if CCI is of the view that an enterprise in question has used IPR granted to it in an unreasonable manner with view to distort competition in the market, it can initiate the investigation. She concluded her lecture by sharing few cases relevant to the topic.

The moderation was concluded with a Q&A round by Ms. Astha Bhatnagar, Assistant Professor, School of Law where the participants actively asked queries and the speaker elegantly offered cogent answers, marking the end of a very illuminating discussion.

Learning Outcome:

The lecture helped the attendees successfully understand the competition law and how it deals with an efficient mechanism to counter anti-competitive agreements, regulating mergers and acquisitions, restricting the use of dominant position etc. On
