INFRASTRUCTURE

The Institute is housed in an aesthetically designed campus surrounded by greenery, in a prime location of East Delhi. The campus is easily reachable having Karkardooma Metro Station and Preet Vihar Metro Stations (Blue Line) at a distance of 1 km., Welcome Metro Station (Red Line) at a distance of 3 kms. and Karkardooma Court Metro station at a distance of 500 mts. only. The spacious well designed building exhibits contemporary architectural beauty and makes it thoroughly enjoyable place for students. The building is installed with complementary ramps and elevators for comfortable access to differently-abled students. The entire campus is Wi-Fi enabled to provide mobility to the users.

SMART CLASS ROOMS

The Lecture Rooms are Air Conditioned and equipped with LCD projectors, Smart Boards and other audio-visual aids well built with state-of-the-art infrastructure facilities and are ergonomically designed so as to give ideal teaching and learning environment.

TEACHING AIDS

To facilitate comprehension of courses by students modern teaching aids like LCD Projector, Smart Board etc. are available to the faculty members. All the faculty members have been provided individual laptops to facilitate teaching and research activities.



LIBRARY-SCHOOL OF LAW

The Law Library is housed with around 11,787 books and back volumes. The Library procures many periodicals including National Journals, 2 International Journals, various Newspapers and Magazines. Of these many Journals viz. AIR have a very rich collection even from the pre-independence period. All books and reference material are bar coded with library automation. The library is an active member of the British Council Library and American Centre Library, New Delhi, to facilitate students for further research. The library also is a member of India's largest and most comprehensive online legal database, *Supreme Court Cases*.



LIBRARY-MANAGEMENT & IT

The Library has a collection of over 12,880 books that supplement the curriculum course content and relevant to the research areas. To provide access to e-resources to students, researchers and faculty of the institute, the library has the membership of *DELNET*. The library provides a good compilation of National and International Journals, Magazines and Newspapers.



COMPUTER LAB

The campus has a state-of-the-art, air conditioned Computer Laboratory, having updated configuration and peripherals. The lab has a capacity to accommodate 100 students working individually at a time. High speed lease line connectivity provides an extended access to vast intellectual resources.



MOOT COURT

The Moot Court activity is an inherent feature of every premier Law School. IIMT (School of Law) in pursuit of professional excellence of its students also engages in honing the mooting skills and aids the same by providing guidance and simulation of the actual court room in the institutes well-equipped air conditioned Moot Court Room. The institution also engages and collaborates with DSLSA & various DSLAs and other institutions of eminence to provide a wider amplitude towards internship and better placement in the later years of the student's career. The institute also organises an annual 'National Moot Court Competition and Trial Advocacy' with the objective to foster learning about the recent developments in the field of law and allied sectors.



SEMINAR HALL

Seminar Hall is well equipped with Air Condition and latest electronics gadgets Teaching - Learning facilities and academic student attend Personality Development Programmes, Workshops, Seminars and Debates, etc.



CONFERENCE ROOM

Fully equipped with Air Condition conference facilities are available in the campus. The conference hall can accommodate around 60 attendees in air conditioned comfort. The audio visual facilities are digitally enhanced and designed for effective presentations with excellent auditory reception.



AUDITORIUM

The Institute has a fully air conditioned well furnished Auditorium fitted with LCD Projector & Audio-Video facilities. It has a seating capacity of over 400 people where all co-curricular activities and other activities are organized.

SCHOLARSHIPS



The Institute awards cash prizes to the meritorious students, who stand first and second in the University Examinations in their respective programmes on annual basis as per the criteria given below:

The student who secures 75% marks and clears all the papers in the first attempt is awarded with a scholarship of Rs. 10,000/- for one year and the second ranker gets a scholarship of Rs. 7,500/-. In case 75% marks are not scored, then the highest between 70% and above is considered as the criteria for second ranker.

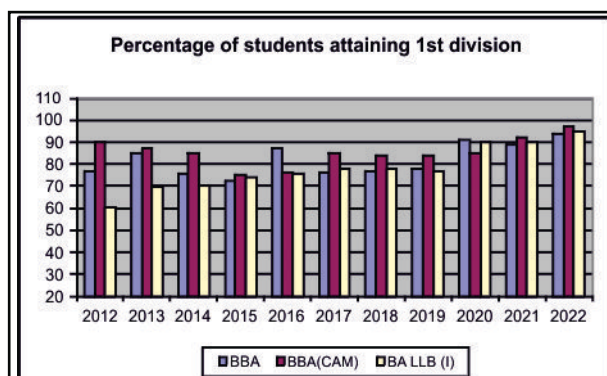
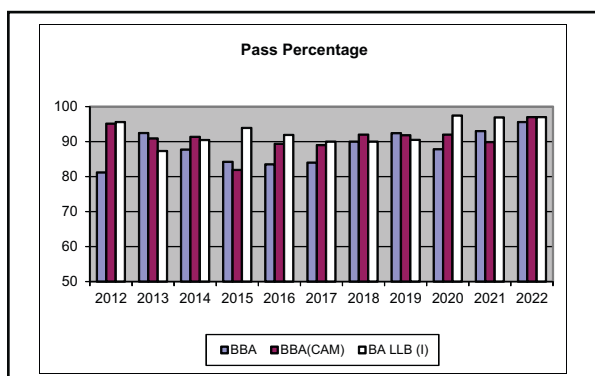
MEMORIAL AWARDS

In order to enhance and enrich the unexplored talent and intellectual capabilities of the students. The Institute has initiated 9 Memorial Prizes in the Law, Management and other areas of Academic and Co-Curricular activities since 11 years at the same time similar criteria has also been instituted for the teaching faculty also.



RESULTS

Our students have a long list of incredible accomplishments to showcase to the community, from academic awards to athletic success. IIMT has proven this when seven students claimed Gold Medal in the University during different years, Urvashi Grover in 2003, Savita Hanspal in 2004, Kanika Nagpal in 2013, Shivalaya Gupta in 2019, Shivani Panda in 2019, Abhishek Jain in 2021 and Priyanshu Bisht in 2022. The alumni of the Institute are placed globally at reputed positions and pursuing higher education from premier institutions. Amongst the recent passout batch, we are proud to announce that 5 of our students are selected as Judicial Officers in state of Delhi, Haryana and Madhya Pradesh and one cleared the prestigious civil services examination and serving the nation as IRS.



PLACEMENTS AND TRAINING

The Ideal Training and Placement Cell (ITPC) is actively working in three different areas:

1. Providing Placement opportunities for the Final Year students. The cell facilitates the process by providing the leads and information to the students and organising On-campus Placement Drives, Off-campus Placement Interviews, Job Fairs and sharing details with students about Central Placements organized through GGSIP University. The Cell also organises Career Counselling sessions for students.

The following sessions have been organised so far :

On 29th August, 2022, a Career Counselling Session was organised, on the topic “Preparation Strategies for Judicial Services”. The speaker for the session was Ms. Divya Sharma, Civil Judge, Class-II, MP.

On 30th August, 2022, A career Counselling Session was organised on the topic “Campus to Corporate” in association with Centum Learning, Bharti group.

On 18th November, 2022, a Career Counselling Session was organised on the topic "Selection of Career after Graduation", The speaker was Dr. Ravi Jaiswal, Registrar, International School of Business and management, Pune.

On 14th December, 2022, a Career Counselling Session was organised on the topic "Career options in Finance and Data Analytics". The speaker was Ms. Prabhjeet Kaur from IMS Proschool.

2. Providing 100% Internship openings to the students. The students of 5th Semester underwent summer internship Trainings as per the requirement of the curriculum. 100% Internship opportunity was provided to the students.

The selection process for the SIP of 2023 has already started and 8 students have been selected for AIM India.

3. Organising Alumni Engagement Activities: The cell works to keep in touch with the alumni through various engagement programmes.

Our Alumni, Ms. Tanya Prabhakar and Mr. Devender Singh were invited as judge for two of the cultural events in Gyan Manthan- the inter college cultural fest of the institute, namely, 'Taal Betaal' – a Singing Competition and 'Shake the Floor' – a Dance Competition.

PLACEMENTS

Since most of the placement activities have been conducted online since March 2020, there were very few On Campus Placement Drives. We received ample support from the Central Career Guidance & Placement Cell of the GGSIPU for the placements & internships of the students.

The CTC offered ranged between Rs. 1.20 lacs to Rs. 6.60 lacs per annum. The average working out to approximately Rs. 3.50 lacs per annum.

SUMMER INTERNSHIPS AND INDUSTRIAL TRAINING

The students of BBA-5th Semester and BBA(CAM) -3rd and 5th Semester have to undergo Summer Internships/ Industrial Trainings as a compulsory component of their curriculum and because of the restrictions arising due to COVID 19, most of the students had to opt for online training. PLACEMENT AND TRAINING (School of Law)

Training and Placement Cell (School of Law) under the able guidance of Prof. (Dr.) Hemlata Sharma (Vice-Principal, School of Law) facilitates the process of placement of students in the final year through off-campus Placement Interviews, Job Fairs and Central Placements organized through GGSIP University besides collaborating with leading organizations and providing internships and training programs to students. It also collaborates with leading governmental and non - governmental organizations. The cell also conducts group discussions, tests and interviews. Career counseling is an integral part of the cell's activities.

This year, the cell is coordinating with the companies online and has already been successful in providing internships to most of the students.

Organizing Alumni Engagement Activities is another part of the cell's activities. Returning alumni have also aided in getting placements for current students.

Internship (BALLB)

The students of BA LLB after their 4th, 6th & 8th semester have to undergo a Compulsory Summer Internship for one month as a part of their curriculum and on that have to submit a report separately. The report is evaluated by a board of examiners and comprehensive viva of the students is conducted for the same.

Further the students of BA LLB 10th Semester have to undergo a full time internship with lawyers/ law firms during the entire semester and keep record of the work done by them in a daily diary. After the completion of internship by the students, the work done by the candidate as recorded in his/her daily diary along with a consolidated internship report is submitted and evaluated by a Board of examiners.

The Students undergo their internships with various senior lawyers and reputed law firms in addition to the Government institutions/ bodies. Naming a few, this year the students did their internships with District State Legal Service Authority, Khaitan and Co. LLP, Singhania & Partners, Twinwood Law Practice Ltd. LEGAL AID CLINIC

The Legal Aid Clinic of the institute offers legal and paralegal services. It has a twin aim of spreading legal awareness and providing free legal assistance to the socially and the economically backward sections of the society who have difficulty accessing the judicial system. Additionally, it also provides a centre for practical and professional hands on training for students of law. The aim of the Clinic is to give effect to the policy and direction of the National Legal Services Authority. Thus, the clinic works closely with the DSLSAs and various DLSAs in Delhi.

PARALEGAL VOLUNTEER TRAINING

With an indispen the Legal Aid Clinic of the Ideal Institute of Management and Technology, under the aegis of Internal Quality Assurance Cell (IQAC), organizes a training session for the students of BALLB in association with Delhi State Legal Services Authority (DSLISA) and District Legal Services Authorities (DLSAs) who inducts the trainees as Para-Legal Volunteers every year. The training is a three days extensive program where the Member Secretary, Special Secretary, Additional Secretary of DSLISA and the secretaries from various district authorities, who all are senior judicial officers, impart training to the students. The prime objectives of this training were:

1. To enhance legal literacy amongst the poor and down-trodden;
2. To ensure that the trainees are service oriented
3. To accomplish the motto of National Legal Services Authority (NALSA), i.e., Justice to All.

After the successful completion of training participants/students become PLVs and become eligible to perform the duties assigned by DSLISA. PLVs also get remuneration for the activities performed.



PERSONALITY DEVELOPMENT PROGRAMMES

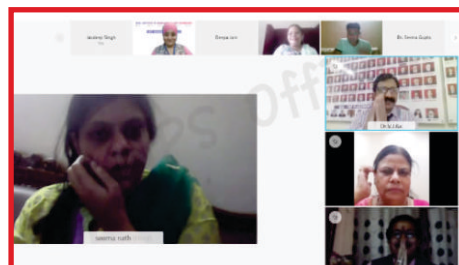

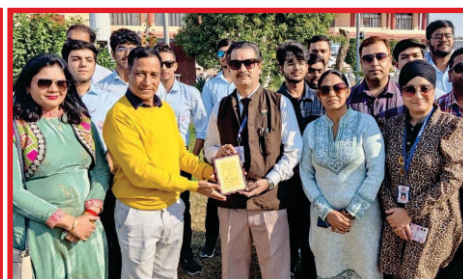
FIELD INTERACTION/ INDUSTRIAL VISITS

GENERAL INSTRUCTIONS

1. The students have to take End Term Examination, which holds 60% weightage. Internal Assessment which includes class tests, assignments, case discussions, quizzes, attendance, projects, class discipline and participation in extra-curricular activities holds 40% weightage for First Year only.
2. The Minimum pass percentage in individual subjects is 40% w.e.f. 01/08/2015.
3. Students failing to secure minimum percentage of marks in individual subjects but passing in the aggregate will have to reappear for the same in the next year.
- 4*. **A student will be promoted to the next academic year only if such students has obtained at least 50%** (rounding to full digits) of the total credits of the existing academic year from which the promotion to next academic year is being sought.
- 5*. A supplement examinations shall be conducted after the declaration of the final year result, only for those regular students who do not have backlog upto the pre-final year courses. That is, supplementary term and examinations to be held only for the courses of the final year for the regular students who have failed only in course of final year. The supplementary term and examinations shall be allowed only to students who have been offered once chance to appear in the examinations of the final year course(s). The teachers continuous evaluation components shall not change in these cases. The supplementary term end examinations shall be held for programmes of studies whose syllabi and Scheme of Teaching and Examination specify this examination.
6. Keep the college neat & clean
7. Silence must be observed in college, library & labs.
8. Entry of visitors/parents through their Id-card after registration at the entrance gate. Use of mobile phones strictly prohibited inside the campus.
9. No entry without uniform on uniform days. No excuse shall be entertained. A reasonable amount of fine/suspension of 7 days or any other action deemed fit shall be taken accordingly against the defaulters.
10. **This is an Institutional Area:** Alcohol, Tobacco consumption, Smoking, Loud music, Honking, Rash driving, Wrong parking is strictly prohibited around the college campus and its punishable as per Law.
11. Parking of vehicles will be at owners own risks.
12. Any loss/damage /theft of personal belongings, money, purse, handbag, mobile, etc. shall be responsibility of the students itself. Therefore, they are advised to take personal precaution to avoid such happenings.
13. Regarding timings of sports like Table-Tennis, Badminton, Cricket and indoor games, etc, contact the sports officer of the institute.
14. Online instructions subject to various notifications of the government.
15. Second and Fourth Saturday shall remain off for all.

RULES REGARDING ATTENDANCE AND DISCIPLINE

The students shall compulsorily require a minimum of 75% attendance in each subject falling which, he/she will not be permitted to take the internal tests/ semester/ annual examination.

Students who has been detained due to shortage of attendance shall not be allowed to be promoted to the next semester and he/she will be required to take re-admission in accordance with the University Rules.

The Institute holds full right to cancel any admission at any point, if a student is found to be misbehaving or any other issue regarding discipline. The Institute aspires to establish high traditions of decency and order. It is expected that the student should imbibe and display a sense of discipline and mutual-respect. The following rules and regulations will be binding on the students :

1. The students of the Institute shall carry their Identity Cards with them while they are in the Institute or when they go to public meetings, excursions, functions etc.
2. Duplicate Identity Card will be issued on payment of Rs. 200/-, after the student has logged at F.I.R. for the lost Identity Card with the Police Station.
3. Students shall reach their respective classrooms on time and shall not enter the classroom without permission of the teacher concerned in case of late arrival.
4. Students should not assemble in front of the classrooms, so that teaching is not disturbed.
5. **At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Director/Principal of the Institution.**

6. Students shall refrain from defacing books, magazines, newspapers etc. of the library and black boards, wall & desks/furniture of the Institute.
7. Leave applications must be sent well in time i.e. latest by next day of the absence. It must bear signatures of the parent/guardian. Medical Certificates must be submitted in stipulated time.
8. Once the student attend the Institute, he/she will not leave the campus unless the permission is granted by the Director or Principal or before the classes are over for the course in which the students is studying.
9. A student suffering from any contagious/infectious disease is not allowed to attend the Institute, till he/she is fully recovered.
10. The Director/Principal, faculty, head of teaching department, librarian and administrator shall have the authority to exercise all such disciplinary powers over students in their respective departments to maintain the decorum and discipline in the Institute.
11. **1+2 attendance will be granted to the students attending/ participating in Independence Day, Republic Day Celebrations, Sports Day and Annual Function (Offline/Online).**

STATUTORY WARNING

12. Cigarette smoking, chewing gum, Pan Masala, Jarda, Gutka, Consuming Liquor is totally prohibited inside & outside premises within 100 meter. Violation of rules will invite a fine of Rs. 1000/- and suspension of 15 days immediately.
13. ***Use of Mobile is strictly prohibited inside the campus and class-room (During teaching-learning process) in the corridors, office and in front of Director's office. Users mobile will be confiscated for a week with a fine of Rs. 500/-. Mobile will be returned to the parents after parents meeting with the Director and written undertaking thereby.***
14. If any student is found indulging in eve-teasing, sexual harassment, violence, fighting, bullying, threatening, intimidating and ragging, will be expelled from the college along with reporting the matter to the police.
15. Online instructions are subject to various notifications of the Govt.

DAMAGING/DEFACING THE PROPERTY OF THE INSTITUTION

If any student is found violating the code of conduct/discipline and/or damaging/defacing the property of the Institute shall be fined Rs. 2000/- for the first time, Rs. 5000/- for the second time. If misconduct is repeated for the third time, his/her name will be struck off from the roll of the Institution immediately.

COMPUTER LAB DECORUM

The Computer Lab is the place of learning the things in lively environment. Your own concentration and dedication will help you to learn. The rules of the computer lab are helpful to you in enhancing your technical and intellectual learning skills, thus preventing you from becoming a sufferer.

The presence of the faculty/instructor will certainly inspire you to learn in a better way, as the saying goes "One man can take the horse to the water but hundred can not make him drink."

Therefore, desire to learn must come from within.

1. No student is allowed to sit in the computer lab during non-lab period.
2. Silence must be observed in the lab.
3. Students will be allotted/assigned computer on 1:1 basis. Each student will use his/her assigned computer. No change of place would be granted under any circumstances.
4. Students found playing a game or performing any activity other than their relevant work would be debarred from entering the computer lab for a week.
5. CDs, Pen Drives & Memory cards are strictly prohibited in the lab without prior permission of the faculty/instructor.
6. After using the computers, check that they are properly shut down and chairs are kept in proper place.
7. Computer tampering in any form is highly punishable.
8. Personal belongings should be kept near the entrance of the lab. Any eatables in possession should be kept out of the lab.

LIBRARY RULES & REGULATIONS

Newton once said, *"I am not sorry why I have spoken, but I am sorry for why I have not kept quite"*. Library is a place where greatest thinkers are born. One visit to the library can change your life. Therefore to utilize and explore the various mental faculties, following rules and regulations are expected to be observed.

1. Timings : For Law - 09:30 A.M. to 04:00 P.M.
For Management - First Shift- 10:00 A.M. to 01.00 P.M.
For Second Shift - 02:00 P.M. to 05:00 P.M.
2. Complete silence is to be observed inside the library.
3. Student's ticket/ Library Membership ID is non-transferable.
4. Reference books and periodicals are not issued out. Issued books returned after due date attract overdue charges. The overdue charges are Rs. 10/- per day.

9. For loss of a book by a member, he/she must replace by procuring it from the market or Pay the current cost of Book(s).
10. Book Bank facility is available.
11. Smoking is strictly prohibited. Keep your mobile phone off within the library premises. Drinks and eatables are not allowed in the library.
12. Threatening and abusive language or behavior is prohibited.
13. Students are not allowed to bring personal books or any printed material and other personal belongings like bags, umbrellas, etc. inside the library. These materials are to be kept at the Property Counter at their own risk. 14. Pasting notices and distributing circulars are not allowed inside the library.
15. Photography, filming and video recording is prohibited inside the library except prior approval of the librarian.
16. Xerox service is provided on payment of nominal charges.
17. If anybody is found violating the rules, he/she will be fined Rs. 500/- failing which the membership shall be temporarily withdrawn for a period of seven days.

Subject: Advisory under Clause 3(ii)(d) of Statute 24 of the University.

Dear Sir/Madam,

The following advisory is hereby issued under Clause 3(ii)(d) of Statute 24 to all affiliated colleges and institutions for compliance and necessary action forthwith;

- a. The teachers and authorities of the Institution should maintain cordial, warm and confidence building relationship with the students in terms of Ordinance No. 32 of the Guru Gobind Singh Indraprastha University Act No. 09 of 1998. The Institution may also keep watch on such teachers and members of administration who are unable to build up such cordial and respectful relationship with students and appropriate remedial measures in the nature of counselling and short term training may be advised.
- b. Every letter /representation/e-mail in the nature of appeal by students should be attended with reformative approach and sympathetic consideration. The Institute should inform the parents of the students by writing the letter intimating the shortage of attendance, which should be sent by speed post / registered post. The parents may also be informed by e-mail or telephonically about such cases.
- c. Institutions should be absolutely transparent in taking the decision on detention of students so as to avoid any suspicion of whimsical or selective action. The detention list should be displayed at least 10 working days before the commencement of the examination.
- d. Every institution should constitute 'Students' Grievance Redressal and Welfare Office'. It should be empowered to receive grievances from students, consider and address them within the framework of the prevailing rules and regulations with the perspectives of the welfare of the students. Such Committee constituted at the level of every college should be publicised and directed to regularly engage in welfare activities of the students, so as to gain the confidence of the students in its effectiveness and genuineness. Such College/Institution level Committee should be federated with the Directorate of Students' Welfare of the University which may supervise and advise them, actively engage them and assist them in redressing the grievances of the students from time to time.
- e. Any issue relating to arbitrary action, personal vendetta or personal grudges against students by any teacher / authority of the Institute should be earnestly looked into by 'Students' Grievance Redressal and Welfare Office' and it should be brought to the notice of Principal / Director of the Institute. If the issues are not resolved at the level of concerned college, the student should be advised to approach the Grievance Redressal Mechanism at the level of the University which shall act as the appellate mechanism.

- f. The University level Grievance Redressal Mechanism for the students, parents, faculty etc. related to affiliated colleges has been constituted and communicated to all concerned vide University letter ref. GGSIPU/Aff/Notification/180-L dated 11.01.2013. All the grievances, communications to the University level Grievance Redressal Mechanism should be addressed to the Convener of the Committee Dr. Neelima Markandey, Affiliation Branch, Administrative Block, Guru Gobind Singh Indraprastha University, Sector 16 C, Dwarka, Delhi 110078.

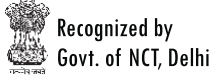
