10 PLVs were deputed at DLSA South for a four day long door-to-door campaign to visit household and aware people about their fundamental rights along with duties and to communicate information regarding admission of kids falling under EWS category and Disadvantaged Groups in primary classes. PLVs visited door-to-door and explained citizens their fundamental rights and duties in layman language. In addition to that, a list containing names and age of children belonging to EWS and DS was also prepared by the PLVs. As many as 5 localities were covered during this campaign. ### SEMINAR (29<sup>th</sup> January, 2020)

The Internal Complaints Committee of the Ideal Institute of Management and Technology under the aegis of Internal Quality Assurance Cell (IQAC) organized a Seminar on 'Gender Sensitization and Awareness of Prevention of Sexual Harassment at Workplace Place Act, 2013' for the students, Faculty Members and non-teaching staff.

In compliance with the instructions of National Commission for women and guidelines issued in implementation of the directives of Hon'ble Supreme Court's Judgment dated 13th August, 1997 in the case of **Vishakha and others vs. State of Rajasthan and Others** on the subject of sexual harassment of women at workplace, the institute has duly constituted a Complaint Committee for considering complaints of sexual harassment of women working in the institute.

The speaker for the day was **Prof. (Dr.) Ritu Gupta, Professor, National Law University, Delhi**, who is also a member of the Internal Complaints Committee of the institute.

The speaker apprised the students with the initiative taken by the government on the topic of 'Gender Sensitization' wherein she started by telling the role of The National Council of Educational Research and Training (NCERT) who has developed syllabus and textbooks across the subjects to promote gender sensitization in the school curriculum. The text books at all stages of school education prioritize gender sensitization in designing of activities/exercises. Central Board of Secondary Education (CBSE) has also prepared guidelines for gender sensitivity in textbooks and textual material, including question papers. The Government of India has already enacted a number of legislations to prevent exploitation/ harassment of women and to address the issues of discrimination and gender disparity. These include 'The Right of Children to Free and Compulsory Education (RTE) Act, 2009', 'The Criminal Law (Amendment) Act, 2013', 'The Protection of Women from Domestic Violence Act, 2005', 'The Dowry Prohibition Act, 1961', 'The Indecent Representation of Women (Prohibition) Act, 1986', 'The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013'; 'The Prohibition of Child Marriage Act, 2006', 'The Equal Remuneration Act, 1976', 'The Maternity Benefit (Amendment) Act, 2017' and the 73<sup>rd</sup> - 74<sup>th</sup> Amendment of the Constitution mandating 33% reservation for women in the local governance. The Criminal Law (Amendment), Act 2013 has been enacted making the punishment more stringent for offences like rape, sexual assaults, etc.

The Government of India is implementing various schemes/ programmes to overcome gender disparity and provide equal status to women in the country. The schemes being implemented by Ministry of Women and Child Development for welfare of women are

- i. Beti Bacho Beti Padhao (BBBP) to improve the Child Sex Ratio and enabling education for the girl children,
- ii. Swadhar Greh Scheme to provide relief and rehabilitation to destitute women and women in distress,
- iii. Ujjawala a Comprehensive Scheme for prevention of trafficking and rescue, rehabilitation and re-integration of victims of trafficking and commercial sexual exploitation,
- iv. Rashtriya Mahila Kosh (RMK) to provide loan to poor women through Intermediary Microfinancing Organisations (IMOs), Non-Governmental Organisations (NGOs) to promote their socio-economic development,
- v. Working Women Hostels (WWH) for ensuring safe accommodation for women working away from their place of residence.

Apart from the above, she threw light on the Ministry of Women and Child Development who has been implementing the scheme of 'One Stop Centre' to provide integrated support and assistance to women affected by violence, scheme for 'Universalisation of Women Helpline' intended to provide 24 hours immediate and emergency response to women affected by violence and scheme of 'Mahila Police Volunteers' in which MPVs act as a link between police and community and help women in distress.

Further, the speaker discussed about the programmes conducted by the Ministry of Women and Child Development in collaboration with National Gender Centre (NGC), Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie on Gender Sensitization for the officers including District Magistrates.

Then the speaker went on discussing the 'Prevention of Sexual Harassment at Workplace Act, 2013 in detail wherein she started with how the guidelines given by the hon'ble Supreme Court in the Vishakha's Case has helped in enactment of The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013. The Act was enacted with the objective to provide protection against sexual harassment of women at workplace and for the prevention and redressal of complaints of sexual harassment and for matter connected therewith or incidental thereto. It defines sexual harassment as unwelcome acts or behavior (whether directly or by implication) namely, physical contact and advances, a demand or request for sexual favors, making sexually colored remarks, showing pornography, any other unwelcome physical, verbal or non-verbal conduct of sexual nature. Any act of unwelcome and sexual nature shall be considered as sexual harassment.


The speaker informed the students that an aggrieved woman can file a written complaint to ICC from three months from the date of the incident and in case of series of such incidents within three months from the last such incident. However, any delay in filing the complaint can be condoned by the committee upto further three months. In case of physical or mental incapability of the aggrieved woman, her legal heirs or such other person as described in Rule 6 of The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rules, 2013 may make a complaint. On receiving the complaint the committee, before initiating an inquiry, may take steps to settle the matter between her and the respondent through conciliation and when a settlement is arrived no further inquiry is conducted. If the conciliation fails or any term of the

settlement arrived at has not been complied with by the respondent, the committee shall proceed further with the inquiry. In case of filing of false or malicious complaint or false evidence the committee may recommend to the employer or District Officer to take action in accordance with the provisions of service rules or where no such service rules exist, in such manner as prescribed in Rule 10 of the Rules.

It was an enriching session for the students.



The Event marked success by getting gaze of numerous individuals of different social economic backgrounds who stopped and watched the street play and asked many queries regarding the subject despite of their language barrier.

At last the volunteers surveyed around 25 people and observed that very few people aware about their fundamental rights and duties and also unaware about the presence of DLSA. The PLV's then taught the objective of DLSA and their Toll free number of i.e., 1516 and about their office at 35 and 35 A in Karkardooma District Court, New Delhi. Queries and problems of people were heard and DLSA forms were filled by the volunteers with the complete details of people who seek legal help so that they can be approached by DLSA.

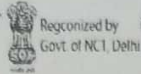

### **Day 1 Session 1 – Inaugural Session by Sh. Kanwal Jeet Arora, Member Secretary, DSLSA Topic - Introduction to Legal Services Authorities Act and its activities & Role and Responsibilities of PLVs**

Kanwal Jeet Arora, Member Secretary, DSLSA as a Keynote Speaker for the day on the topic 'Introduction to Legal Services Authorities Act, its activities & Role and Responsibilities of PLVs'. The session was conducted to aid the students with the insightful experience and understanding of the key aspects, historical development and on the very need of the Legal Services Authorities Act via the statute's preamble i.e. distribution of equitable justice and the viable execution of welfare provisions.

The Speaker in his well-structured lecture provided a broad outlook of the statute wherein he briefed the Composition, Powers, and Functions of various levels of legal services authorities and the working of Lok Adalats. Sir also shared the main aim and objective of the statute i.e. to promote an inclusive legal system to ensure fair and meaningful justice to the marginalized and disadvantaged sector and the role of the PLVs in attaining the said objective. He also sensitized and

highlighted the need for a 'community driven drive' in the participants sharing his vast experience  
three decades.

Sushant Changotra, Additional Secretary, DSLSA, Ms. Namrita Aggarwal, Special Secretary, DSLSA and Ms. Saema Jamil, Secretary East DLSA with a Shawl, Memento, and Holy Bhagwata Gita. The session was followed by a lecture on the topic "Introduction to Legal Services Authorities Act and its activities & Role and Responsibilities of PLVs" and the session was concluded by a Vote of Thanks proposed by the anchor of the session Ms. Anjali Nair, Member, Legal Aid Clinic.

#### **Day 1 Session 2 by Mr. Sushant Changotra, Additional Secretary, DSLSA**

##### **Topic - 'Laws on Children with special emphasis on Cyber Crime'**

The speaker shared several real-life episodes and experiences that stirred the minds of the participants and generated curiosity and interest. **Topic - "Laws Relating to Women"**

**Topic - "Relating to the filing of RTI for seeking the information from Public Authorities"**

K.S Kumar Former Director, Ministry of Defence on the topic "Right to Information Act" which included elaboration on the filing of RTI for seeking the information from Public Authorities. #### **Topic –“Constitutional Vision of Justice”**

The program included a diverse understanding of Justice and its viability in the present society. After encompassing the domain of Justice, the PLVs were then sensitized towards the practical legal aspects that students need to understand in procedure as applicable in society. The training program was then continued with questions and answer session where students asked a wide array of questions related to the topic.

The session was then followed by the presentation of Memento to the reverend speaker for the day for the gracious presence and deliverance on the very topic this was concluded by a Vote of Thanks given by Mr. Eesh Singh, Assistant Professor, IIMT.

### **Day 3 Session 2 by Mr. Sumeet Anand, Secretary, DLSA (New Delhi)**

#### **Topic –“Laws Relating to Senior Citizens and Laws relating to Transgender”**

The Training session comprised of a lecture and dialogue with the Revered Judge Sh. Sumeet Anand, Secretary, New Delhi DLSA as a keynote speaker for the day on the topic “Laws Relating to Senior Citizens and Laws relating to Transgender” in which the students were made aware of the aspects of Maintenance and Welfare of Parents and Senior Citizens Act, 2007.

During the session the PLVs were sensitized about the well-being of older persons as mandated under Article 41 of the Constitution of India which directs a State within the limits of its economic capacity and development to make effective provision for securing the right of public assistance in cases of old age. The speaker also referred to provisions under other personal laws including the Hindu Adoptions and Maintenance Act, 1956 and Section 125 of the Criminal Procedure Code, 1973 which specifically provides for maintenance from children if parents are unable to maintain themselves but cases are rarely filed by parents due to love and affection, fear of stigma, and time and money required for the legal proceedings. The speaker also focused on the laws relating to transgender in which he stressed on the point that Justice still has not been provided to them even after the law has been implemented and also shared that he has asked to introduce a special toilet for the transgender in the Legal Services Authority.

The session was then followed by the presentation of Memento to the reverend speaker for the day for the gracious presence and deliverance on the very topic this was concluded by a Vote of Thanks given by Mr. Eesh Singh, Assistant Professor, IIMT.

### **Day 3 Session 3 by Mr. Himanshu Sehlot, Secretary, Central DLSA - II**

#### **Topic –“Labour Laws”**

The Training session comprised of lecture by Mr. Himanshu Sehlot, Secretary, Central DLSA II, as a keynote speaker for the day on the topic Labour Laws where the speaker focused on the role of both Parliament and state legislatures can make laws regulating labor. The speaker focused on the Second National Commission on Labour (2002) (NCL) which found existing legislation to be complex, with archaic provisions and inconsistent definitions and the importance of improving ease of compliance and uniformity in labor laws. The speaker referred to the 2019 bills by the Ministry of Labour and Employment where a consolidated labor code was introduced to consolidate 29

central laws. These Codes regulate (i) Wages, (ii) Industrial Relations, (iii) Social Security, and (iv) Occupational Safety, Health, and Working Conditions.



#### **Day 3 Feedback Session 4 by Mr. Sumeet Anand, Secretary, DLSA (New Delhi)**



The event was graced by the august presence of the Sh. Pranat Kumar Joshi, Secretary DLSA Shahdara District, Sh. Vinik Jain, Secretary, North-East DLSA, and Ms. Saema Jamil, Secretary, East DLSA as distinguished guests

The Programme witnessed a lecture and a dialogue by the revered judges as the keynote speakers for the day. The Programme was organized with the aim to provide the students with an insightful experience and understanding of the key aspects of related laws along with the societal constraints of the present-day world.

The Programme commenced with the lighting of the lamp and felicitation of the Hon'ble speakers and dignitaries. The first session was delivered by Dr. Parikshet Sirohi, Assistant Professor, University of Delhi. He discussed the legal aspect and provisions related to Cyber Crimes. Dr. Sirohi initiated the talk by putting emphasis on the significance of data via-a-vis one's privacy. He also put forth his views on the possibility that the next World War can take place because of violations of Cyber Data. His talk geared toward various facets of Cyber Stalking, Extortion, Spoofing, Cyber Crimes, and Cyber Forensics. He also discussed various crime investigation case studies, and the session also witnessed discourse on Privacy Policies for various applications that are freely available to society at large. Dr. Sirohi advised the usage of disposable E-mail Accounts, and explained the implications of the same. He also discussed the NETIQUETTES – the network etiquette, the dos and don'ts of online communication. He apprised the gathering about various Certificate Courses offered by Universities in India. His talk concluded with the usage of security countermeasures from AdBlock Plus, Dumpster, ChatSecure.org, VirusTotal.com, downtrace, and others. Dr. Sirohi concluded by cautioning the audience of the consequences and urged everyone to take precautions to safeguard against cybercrimes.

Thereafter, the second session was delivered by Inspector Sanjay Kumar, S.H.O. Cyber Police Station, Shahdara, Delhi. He explained that every citizen is living in two worlds simultaneously. One is the "REAL" world, and the other is the "VIRTUAL" world. While existing in the real world, we take all security precautions possible to remain safe and secure. In spite of knowing the laws, most of us operate otherwise. He discussed in-depth knowledge concerning different types of cybercrimes such as Access to Data without Permission, Data Theft, Damaging Computers, Denial of Access, Access to Unauthorized Persons, Identity Theft, Cyberstalking, and Cyber Terrorism. The preventive measures to be taken to safeguard oneself were also discussed at length. Thereafter, the gathering was sensitized towards the legal aspects which were eloquently taken by the Hon'ble Judge and Speakers for the day. The Awareness Programme then proceeded towards the Question-Answer Round. The round aided in furthering clarity over the concerned topic.


The concluding remarks were given by Sh. Pranat Kumar Joshi, Secretary DLSA Shahdara District. He advised to be cautious of the cousin domains (which are the deceptively similar to the domains of trusted websites and companies). He extensively addressed various possible solutions that an individual can go through for avoid online Scams. Mr. Joshi brought into light the implications and repercussions the offense of sextortion, i.e. a practice of extorting sexual favors from someone by threatening to reveal evidence of their sexual activity. He also brought to notice the improper use of Artificial Intelligence. He emphasized the need to

sanitize each person's phone by revoking unnecessary permissions, uninstalling unwanted applications, and deleting sensitive information to ensure that a step is being taken to protect against the ocean of new-age cybercrimes.

Thereafter, a letter of appreciation was presented to the revered speakers and distinguished guests for their gracious presence. A formal Vote of Thanks was delivered by Ms. Perna Gulati, Sr. Assistant Professor, School of Law, IIMT.






**NSS Report**

The event commenced by welcoming the hon'ble chair along with the revered and learned guests to the auditorium. The luminaries, thereafter, paid tribute by lighting the lamps and

showering flowers on the idol of Goddess Sawaswati to evoke blessings of the 'Goddess of Knowledge, Art and Wisdom'.

The tone of the Session was laid down by the In-Charge of the Clinic, Mr. Jasdeep Singh in form of the concept note delivered at the very outset of the session. Thereafter, the dignitaries were honoured for their august presence via a felicitation ceremony.

The Director of the Institute Prof. (Dr.) Anil Parkash Sharma in his welcome address commended the efforts of the convening team in organizing the session themed around the current situations of Harassment of Women and Cyber Crime, and providing an active platform for sensitizing those present and involved around the issues and challenges faced in bringing about the coherence of the same.

The revered speaker for the day Prof. (Dr.) Ritu Gupta, National Law University Delhi was graciously called upon for the distinguished talk. Madam commenced the session with the way the guidelines given by the hon'ble Supreme Court in the *Vishakha's Case* has helped in enactment of The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013. The Act was enacted with the objective to provide protection against sexual harassment of women at workplace and for the prevention and redressal of complaints of sexual harassment and for matter connected therewith or incidental thereto. It defines sexual harassment as unwelcome acts or behavior (whether directly or by implication) namely, physical contact and advances, a demand or request for sexual favors, making sexually colored remarks, showing pornography, any other unwelcome physical, verbal or non-verbal conduct of sexual nature. Any act of unwelcome and sexual nature shall be considered as sexual harassment. The speaker also informed the students that an aggrieved woman can file a written complaint to ICC from three months from the date of the incident and in case of series of such incidents within three months from the last such incident. However, any delay in filing the complaint can be condoned by the committee up to further three months. In case of physical or mental incapability of the aggrieved woman, her legal heirs or such other person as described in The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rules, 2013 may make a complaint. On receiving the complaint the committee, before initiating an inquiry, may take steps to settle the matter between her and the respondent through conciliation and when a settlement is arrived no further inquiry is conducted. If the conciliation fails or any term of the settlement arrived at has not been complied with by the respondent, the committee shall proceed further with the inquiry. In case of filing of false or malicious complaint or false evidence the committee may recommend to the employer or District Officer to take action in accordance with the provisions of service rules or where no such service rules exist, in such manner as prescribed in the Rules. The talk provoked the audience to deliberate upon the current social situation and the way the same is being implemented in the nation.

Thereafter, the session shifted to its next and final leg wherein the revered keynote speaker Dr. Pavan Duggal, Advocate, Supreme Court of India addressed the audience via video

conferencing. He laid forth the laws relating to Cyber Crimes in India, and also while deliberating put a lot of emphasis on the legal remedies available for the deprived. The remedial forums were explained in detail to the gathering. The hon'ble speaker also lay light upon the increasing use of the cyber space and urged the audience to put the resources to use in a safe manner. The gathering was witnessed deliberating upon the positives and the negatives of the social and other platforms available.


The sessions were followed by a moderation round wherein the students asked their queries, and the organizers witnessed the same being answered by the speakers in an elaborative and illustrative manner.




The programme observed its conclusion in the shape of a National Song of India. The attendees stood and paid their respect and gratitude towards our motherland.

## ACTIVITY NO. 3

### REPORT ON BLOOD DONATION CAMP



Blood can save millions of lives, and young people are the hope and future of a safe blood supply in the world. Blood transfusion is crucial for health care systems, which contributes to rise in life expectancy and quality of life of people experiencing acute critical illness or chronic diseases.

#### **Introduction:**

A blood donation camp was organized in the institute which was a student initiative and blood donation awareness was carried out at different parts of the institute. For this reason, the study aimed at assessing the knowledge, attitude, and practises among the voluntary donors was carried out to bring out further awareness programs.

How did they organise the Camp?

IIMT, along with 37 NSS Candidates have taken part in this Camp. All the members of NSS were present during the Programme.

The idea to conduct a blood donation camp in the slum of Madanpur Khadar Sangam Vihar in Paharganj , Delhi was initiated by the students of the 2<sup>nd</sup> year and was implemented on December 27<sup>th</sup> 2022. For this, the students had also designed posters regarding blood donation and distributed or pasted on the walls of the streets to spread awareness. The activity of blood donation was executed by a group of 19 team members under the guidance of faculty members. Each donor was taken care of by looking after any post donation weakness or nausea & was also provided with refreshments. At the end, feedback was also taken from the donors.

## Results:

Out of the 50 donors, there were 21 male (42%) and 29 females (58%). It was recognized that, among 50 donors, 52% of the donors have not donated in the last 2 years while 58% of the donors would voluntarily like to donate blood again. It was seen that 52% of the donors had fear of needles acting as a hindrance for the blood donation.

## Conclusion:

Their experience during the whole journey of the initiative was quite enlightening. Looking at the enthusiasm of the donors and the organizing team. The success of the event has further encouraged me to carry out such more awareness projects in the future.

## ACTIVITY NO.4

### (REPORT ON ROAD SAFETY CAMPAIGN)



Roads are not the place for you to showcase your stunts or experiment with drifting techniques, no matter how empty the roads are. Penalties for traffic rule violations are updated on a regular basis to keep the number of road accidents in check. The main goal of all these is to regulate the flow of vehicles and promote safe travel conditions for all.

Some examples of penalties for traffic violations are a fine of two thousand rupees and imprisonment of up to 3 months if you are found driving without valid insurance for your motor vehicle. Use of vehicles without a license can be charged with a fine of thousand to five thousand rupees. Vehicles running without a permit would have to pay a fine of ten thousand rupees and/or a period of six months of imprisonment or community service.

#### **Some Things You Should Know if You Love to Travel**

Ever seen a road signal with an inverted triangle and wondered what it meant? Ever felt confused about what hand signal it was that the one who drove the vehicle in front of you was trying to indicate? Well, these are the kind of situations you should never come across when you are on the road. Here are a few points that you should try to check off your list before you start your journey.

- Keep yourself well-informed about the traffic regulations of the state or country you are travelling to.
- Have contacts of police helplines for emergencies.
- Keep your vehicle serviced and ready along with backup.
- Carry a map so that you know where exactly to go, and to avoid any sort of confusion on your way.

Now, when you are driving, the following are a few things that you should take utmost care of.

- When you wear helmets, do not forget to fasten the straps.
- Use of seat belts by drivers and co-passengers.
- Do not listen to music too loudly to the extent that you cannot hear horns or lose your concentration.
- Be conscious of the road conditions. Go slowly and carefully.



Always be prepared to face any emergency when travelling.

- Carry a first aid kit.
- Keep emergency contacts on speed dial.
- Be ready to help in case you find someone injured.

### **Their Experience at Road Safety Camps**

The campaign they worked at was done in Mandawali, New Delhi near Mother's Convent School so that the children there will be able to learn more about safety rules and regulations. Although my job was to volunteer to teach young children about safety rules, they got to learn more about the safety rules they must follow and how they should teach the younger generations so they can follow these rules while travelling. Children need to be taught the language of road safety before they can understand the rules. For example, names of vehicles, names of street furniture such as pavements and kerbs, and an understanding of fast, slow, looking, listening, and crossing.

I got to know a lot about new traffic rules that has been inculcated recently. These traffic rules were introduced in 2020 and many children were unaware of these rules, some of them were as follows:

- If the driver is caught talking on a mobile phone while driving, then other than having to pay a fine, the police can confiscate the mobile phone for a period of 24 hours. This order was issued by the Nainital high court.
- If any driver violates any of the traffic laws, other than having to pay a fine, the driving license can be cancelled or temporarily suspended by the same RTO where it is issued. This order comes from the Jodhpur bench of the High Court.
- Pune and Bengaluru have banned the use of loud silencers on motorcycles as these cause a lot of noise pollution and even reduce the emission control of the vehicle. They also cause a safety hazard by disturbing others.

The National Practices for Early Childhood Road Safety Education have been developed by early childhood education. The National Practices for Early Childhood Road Safety Education guide early childhood educators and curriculum developers in implementing road safety education programs that maximise a child's learning about road safety in the context of family and community. Overall, it was a great learning experience and it was so fulfilling to be able to help those children who wanted to learn about the safety rules.

**ACTIVITY NO. 5**  
**(REPORT ON HEALTH CAMP)**



Health Camps are mobile and are conducted in different locations by qualified doctors, nurses, and paramedics and community health workers. In most cases, these health camps are funded by NGO's, Trusts or renowned Hospitals. Health camps are organized to help the poor to get healthcare free of cost. What is Health Camp and what are the Guidelines for Successful Health Camp.

When many hospitals organize free camps, a sizeable number of patients turn up because medical services are given free of cost. Later, these patients do not make it to the hospital for further check-ups because they feel it's too costly to pay a visit. NGOs and Medical Trusts also organize free medical camps and in many cases, people are seen to show up for further treatment in the recommended hospitals because those treatments are entirely funded by the Trust or NGO's.

Before organizing the camp there are a few things you need to consider such as the source of fund, time, the goal of the camp, approximate number of participants you are expecting to attend the

camp, number of personnel you need to choose to conduct the health camp such as doctors, nurses, pharmacists etc.

There should be health workers or volunteers to assist these individuals when it comes to handling the participants during activities by maintaining a disciplined environment in the camp. The people whom you will hire must be physically fit to handle the pressures of working in the camp. They should also be prepared to mingle for a span of time with individuals who have different needs and health problems.

### **Top Requirements to Organize a Free Medical Camp**

- Staff members like doctors, nurses, technicians, lab assistants, physiotherapists, dieticians, office assistants, supportive staff like drivers and helpers will be needed.
- Other facilities that should be provided at health camp are safe drinking water, toilets for staff and patients, facilities for waiting area.
- For patient and attendants, water, food packets should be available if decided to supply. hygiene and safety of food should be maintained to prevent transmission of infections.
- Educational material like posters informing about diseases like Cancer, HIV, Kidney problems, Stroke, Mother and Child health, Polio, Immunization, Rabies, Prophylaxis should be carried.

### **My Experience at Health Camps**

The health camp was done at a slum in Janta colony, Subhash Park. Although my role was to help out the doctors, they learnt many other things during this camp. For example, the harsh conditions that these people were living in. For over 10 years they have been staying in 10×8 foot huts with no bathrooms. The children there do not have any footwear and maybe 5% out of 300 kids, actually go to school. Young kids with physical and mental disabilities are left alone at home the whole day while their parents go to work. To earn their livelihood both parents are forced to work and can't afford to stay home with kids.

I was exposed to many new diseases that they had no clue existed. This included nephrotic syndrome and Cerebral palsy. Cerebral palsy occurs because of a brain injury or malfunction before it is fully developed. They was able to converse with a young girl, who was suffering from this disease, with nothing but small gestures. She was really enthusiastic and inspiring and conversing with her was an unforgettable experience. By the end of the camp almost 20 out of 80 kids were found to be malnutrition and suffering some type of chronic infection. This is probably due to their

harsh living conditions where they burn materials inside and by their houses. They also don't have toilets so overall it was a very unhygienic and unhealthy environment for anyone to live in.

In terms of oncology, there was one woman whose cervix was abnormal and bleeding. All major cases were referred to Rajiv Gandhi Super Speciality Hospital, the hospital which provided the doctors, for follow-ups and treatment. Overall, it was a great learning experience and it was so fulfilling to be able to help those who really need medical assistance!
