





As you are aware that Ambient noise levels are more in public places contributed from various sources, inter-alia, industrial activity, construction activity, fire crackers, sound producing instruments, generator sets, loud speakers, public address systems, music systems, vehicular horns and other mechanical devices have deleterious effects on human health and the psychological well being of the people. Noise Pollution (Regulation and Control) Rules, 2000 has been notified under the Environment (Protection) Rules, 1986, vide S.O. 123(E) dated 14th February 2000 and as amended, for the regulation and control of noise producing and generating sources. The said rules specify ambient air quality standards in respect of noise for different areas/zones i.e. industrial/ residential/ commercial/ silence zones/ areas

Further, Hon'ble National Green Tribunal vide its order dated 14.03.2019 in OA 519/2016 titled as Hardeep Singh & Ors Vs SDMC & Ors has also made reference to the orders of Hon'ble Supreme Court of India dated 1st July, 2005 in WPC No. 72 of 1998 with Civil appeal No. 3735 of 2005 and Noise Pollution (Regulation and Control) Rules, 2000 as amended to date, in which special awareness campaigns for noise pollution control have to be conducted. There are clear cut directions in the order of Hon'ble NGT to exclusively nominate one DCP (Police) and SDM for constitution of Joint Committee which will look after the issues related to the noise pollution.

Hence Considering the need for mass awareness & large public participation for effective implementation/ enforcement of the existing norms/ regulations for controlling Ambient noise levels due to various sources, a workshop is being organized on 16th April, 2019 from 9:30 AM till 2:00 PM at Auditorium, Delhi Secretariat, IP Estate, New Delhi. Chief Secretary, Delhi will inaugurate the workshop at 10:00 AM.

Let us explain the manufacturing process- first they make compound by mixing diff. Chemicals and then they compress it into different sheets, they keep the temperature of that machinery at 100°C and after that they wash those sheets to go further in this process, like cutting/ separating the base and straps at same level, at last they print over the slippers to make them finishing goods by joining those straps and further washing them in cold water.

The best part of this industry was that they actually encourage women empowerment as we observed 50 percent of their employees are women. And every employee was very concentrated towards their work. Overall it was observed that there was quiet a friendly environment of management. The superior's and the employees were having a good working relationship as they both were showing gratitude towards each other.

At last, the visit ended with enriching and valuable experience which helped the students in getting useful information related to the practical aspects of the course and the management concepts which cannot be visualized in lectures i.e. Planning, Organizing, Staffing and Controlling and the various stages of production process.
