RULES AND REGULATIONS

1. NAME OF THE ASSOCIATION : IDEAL INSTITUTE ALUMNI ASSOCIATION

2. ADDRESS : 16 X, Karkardooma Institutional Area, Delhi - 110092

Admission of membership to the Association shall be at the sole discretion of the Managing body of the Association and the managing committee may reject any membership at the time of admission or after admission without assigning any reason.

4. SUBSCRIPTIONS : Life membership fee Rs.1,000/- at the time of admission.

5. TERMINATION OF THE MEMBERSHIP

The membership of a person is liable to be terminated/ ceased under the following situations:-

- (a) When he has committed moral turpitude and declared unqualified to hold an office.
- (b) When such person has been convicted for an offence by a Court.
- (c) When such person has not paid the dues of the Association and the default has been for six months or more.
- (d) When such person has acted in a manner prejudicial to the interests of the Association.
- (e) When he has become insane, insolvent or mentally deranged.
- (f) When such person behaves in an objectionable manner in a drunken or intoxicated state.
- (g) When such person voluntarily resigns from the membership.

In the event of dispute or difference of opinion on the point of termination of membership among members or office bearers, it would be decided by the majority of votes.

6. RE-ADMISSION

The application for re-admission of the terminated members will again be placed before the managing committee of the Association for consideration, and they would be admitted again by the managing committee of the Association on the payment of all the arrears of dues, if any. The managing committee however can refuse the re-admission without assigning any reason.

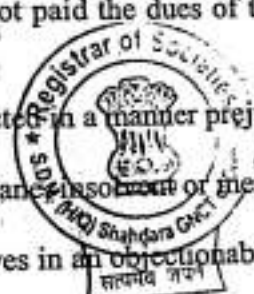


All the appeals shall be preferred to the General Body of the Association and the decision of the General Body shall be final and binding on all its members.
